ORDINANCE NO. 23-AN ORDINANCE AMENDING BREVARD COUNTY CODE OF ORDINANCES CHAP-TER 110 UTILITIES. AMENDING RATICLE II. WATER AND SEWER SYSTEMS. AMENDING SECTION 110-36. DEFINI-TICAL MULTI-UNIT RESIDENTIAL COM-PLEX; AMENDING 110-70. FATS, OIL, AND GREASE MANAGEMENT PROGRAM. TO PROVIDE FOR COMPLIANCE REQUIRE-MENTS FOR VERTICAL MULTI-UNIT RESI-DENTIAL COMPLEXES; AMENDING 110-72. FATS, OIL, AND GREASE MANAGE-MENT PROGRAM CRITERIA. TO PROVIDE FOR THE DETERMINATION OF THE CAUSE OF FATS, OIL, AND GREASE OB-STRUCTIONS; AND PROVIDING FOR AREA ENCOMPASSED; ENFORCEMENT; CONFLICTING PROVISIONS; SEVERABILITY; CODIFICATION; AND EF-FECTIVE DATE.

All persons for or against said ordinance can be heard at said time and place. If a person decides to appeal any decision made by the Board with respect to such hearing or meeting, he/she will need to ensure that a verbatim record of the proceedings is made, which record in-cludes the testimony and evidence upon which the appeal is based.

The needs of hearing or visually im-paired persons shall be met if the de-partment sponsoring the Public Hearing is contacted at least 48 hours prior to the public meeting hearing by any per-son wishing assistance. The sponsoring department is the Utility Services De-partment, 321-633-2091.

A copy of the ordinance may be request-ed from the Utility Services Department or the County Manager's Office.
