## **ASSIGNMENT OF AGREEMENT**

This Assignment is made and entered into on the date of the last signature below, by and between the BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS, a political subdivision of the State of Florida (hereinafter "Brevard County"), WSP USA ENVIRONMENT & INFRASTRUCTURE INC. (hereinafter "WSP USA/Assignee"), and WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC. (hereinafter "Wood/Assignor").

WHEREAS, on January 28, 2020, Brevard County entered into an Agreement for professional services for some or all aspects of engineering services such as geotechnical investigation, environmental permit applications, bidding and construction management services, civil & stormwater design, seagrass and wetland surveys, delineation and mapping, protected species permitting and relocation, mitigation/restoration project design, implementation, monitoring and reporting, feasibility studies and design evaluation for dredging, effluent treatment and dewatering technology for sediment/demucking management projects with Wood (hereinafter "Agreement"); and

WHEREAS, Wood/Assignor wishes to assign all of its rights and duties under the Agreement with written approval from Brevard County; and

WHEREAS, WSP USA/Assignee hereby accepts the assignment of all Wood/Assignor's obligations, responsibilities, and duties under the contract and all of Wood/Assignor's rights, title and interest in and to the Agreement.

NOW, THEREFORE, for value received, and other good and valuable consideration, the parties hereby agree as follows:

- 1. The above recitals are true and correct and are incorporated herein in their entirety by this reference.
- All rights, title and interest in the Agreement between Brevard County and Wood/Assignor are hereby assigned and transferred to WSP USA/Assignee, and WSP USA/Assignee accepts said assignment and agrees to perform all obligations of Wood/Assignor under the Agreement.
- 3. WSP USA/Assignee agrees to abide by all terms, prices and conditions of the Agreement.
