Discussion

Brevard County collects educational facilities impact fees from residential development for construction of educational facilities or capital improvements that provide educational capacity in the Impact Fee Benefit District from which the funds were collected. The funds may be used on capacity projects identified in the Five-Year District Facilities Work Program.

The process by which funds are allocated to projects is outlined in the Interlocal Agreement between Brevard County and the School Board. Each Benefit District (North and South) has an Educational Facilities Impact Fee Benefit District Advisory Committee that includes the School Board, County and applicable municipal representatives. Approximately every quarter, the District Advisory Committees make a recommendation to the School Board. The School Board approves or modifies the recommendation and then submits the funding request to Brevard County for approval by the Board of County Commissioners. The process can take 2-4 months before the funds are received by the District.

The Board action requested allocates the impact fee revenue collected through the quarter ending June 30, 2023. Additionally, this request reallocates impact fees previously allocated to the South Area Elementary School project and the North Elementary Capacity project.

The Impact Fee Benefit District Advisory Committees met on July 10, 2023. The Committees' recommendations for new educational facilities impact fees through June 30, 2023, along with reallocation of previously allocated impact fees are attached to this agenda memo and are summarized as follows:

- Allocate new impact fees collected in South Benefit District to Central Area Secondary \$6,373,149.55
- Reallocate impact fees from South Area Elementary School to South Area Elementary Capacity \$2,793,352.49
- Reallocate impact fees from North Area Elementary Capacity to Debt Service \$1,271,784.02
- Allocate new impact fees collected in North Benefit District to Debt Service \$2,147,765.29

The Central Area Secondary project includes the classroom building addition at Viera High School and the new middle school on the site next to Viera High School (referred to as "Middle School X" in our Five-Year District Facilities Work Program). The Viera High School classroom addition project is fully funded, so the proposed allocation will be used for the new middle school. The financing plan for the middle school was presented to the Impact Fee Benefit District Committees, noting that the District staff will request allocation of the South Benefit District impact fees to the new middle school for through +/- 2025 to minimize the amount of financing required.

The current South Area Elementary Capacity project is the classroom addition at West Melbourne School for Science. The project is under design and the cost estimate is \$8.2 million. The request is to reallocate funds from the South Area Elementary School

project to the South Area Elementary Capacity to fund the classroom addition at West Melbourne. The next elementary project in South Brevard is expected to be a new elementary school in the Palm Bay area based on growth projections.

The allocation of north area impact fees to debt service (\$3,419,549.31) will reduce the amount of local capital funds required to pay debt service. Capital funds saved can then be designated for the classroom building project at Mila Elementary, which is located in the North Benefit District. The Mila project is in the pre-design phase with stakeholder engagement to determine the scope of the project. Since educational impact fees can only be used for additional capacity, a building replacement project would not be an eligible use. Consequently, utilizing the north area funds for debt service and designating the resulting available capital funds for the Mila Elementary project will keep the investment of north area funds in the north area.

Recommendation

Approve the recommendations of the Educational Facilities Impact Fee Benefit District Advisory Committees:

- Allocate new impact fees collected in South Benefit District to Central Area Secondary \$6,373,149.55
- Reallocate impact fees from South Area Elementary School to South Area Elementary Capacity \$2,793,352.49
- Reallocate impact fees from North Area Elementary Capacity to Debt Service \$1,271,784.02
- Allocate new impact fees collected in North Benefit District to Debt Service \$2,147,765.29

Authorize the Superintendent, or designee, to request Brevard County approve the allocation request and disburse the Educational Impact Fees available through June 30, 2023.

Approve designating \$3,419,549.31 in capital funds for the Mila Elementary classroom building project pending approval and disbursement of the recommended allocation of educational facilities impact fees by the Brevard County Commission.


