All rights, title, easements, and appurtenances in and to Rockledge Drive are vested in Brevard County, Florida, in accordance with Section 95.361, Florida Statutes.
- 3. This Resolution shall be recorded in the Public Records of Brevard County, Florida, immediately upon adoption.
- 4. This Resolution shall take effect immediately upon its adoption.
