**RELEASE OF RESERVATION OF RIGHT OF ENTRY  
FOR THE PURPOSE OF EXPLORATION FOR  
PHOSPHATE, MINERALS, METALS, AND PETROLEUM**

**KNOW ALL MEN BY THESE PRESENTS:** That BREVARD COUNTY, a political subdivision of the State of Florida, for and in consideration of mutual benefits, has released and by these presents does release unto TITUSVILLE-COCOA AIRPORT AUTHORITY, a special taxing district of the State of Florida, its successors and assigns, the right, interest, claim, and demand consisting of the right of entry for the purpose of exploration arising out of the following reservation, to-wit,

an undivided three-fourths interest in, and title in and to an undivided three-fourths interest in, all the phosphate, minerals, and metals that are or may be in, on, or under the said land and an undivided one-half interest in all the petroleum that is or may be in, on, or under said land with the privilege to mine and develop the same.

The reservation was by virtue of Section 270.11, Florida Statutes, and that certain County Deed to Titusville-Cocoa Airport Authority, recorded August 28, 2009, in Official Records Book 6017, Page 656, and that Corrective County Deed recorded October 5, 2011, in Official Records Book 6464, Page 1233, both of the public records of Brevard County, Florida, conveying, the following described land situate, lying and being in Brevard County, Florida to wit:

**PROVIDED, HOWEVER,** this release affects only those lands particularly described in Exhibits "B" and "C" attached hereto and by reference made a part hereof, lying and being in Brevard County, Florida, and the aforementioned reservation is hereby retained over all other lands not previously released from said reservation. This release does not release Brevard County's oil, gas, or other mineral interest, only the right of entry for the purpose of exploration.

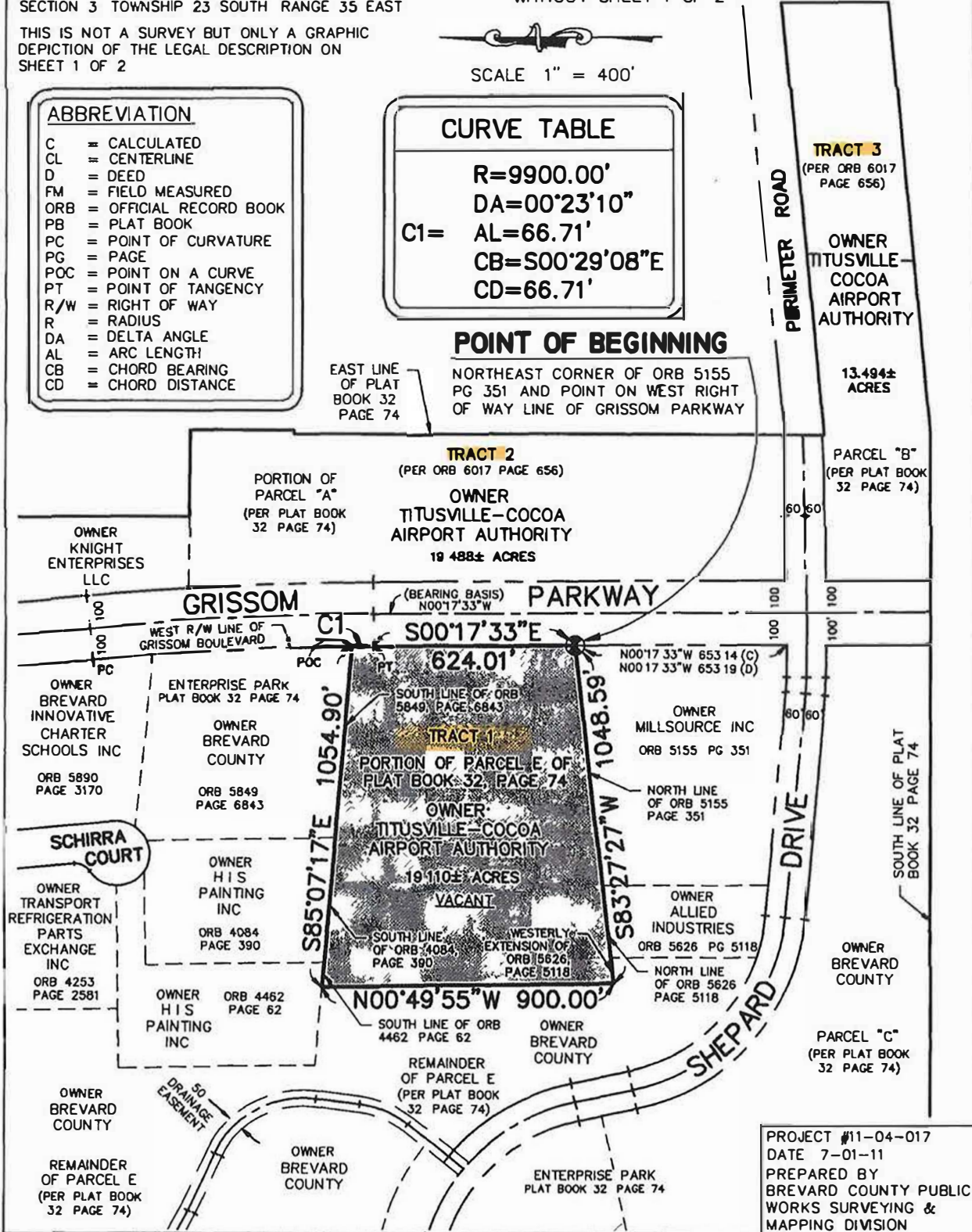
