RESOLUTION

WHEREAS, Brevard County Ordinance No. 73-17 authorizes the establishment of a schedule of fees and charges for the public procurement of various documents and services; and

WHEREAS, the aforementioned Ordinance further provides for the collection of monies in accordance therewith; and

WHEREAS, the Board of County Commissioners of Brevard County, Florida, has determined that the fees hereinafter specified are reasonable.

NOW, THEREFORE BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, that:

Section 1. Establishment of Schedule of Fees and Charges.

A schedule of fees and charges as specified herein established and adopted for the Brevard County Environmental Services Division, Utilities Engineering, as follows:

Item

Utilities Construction Plan Review Fee:

(For projects requiring Florida Department of Environmental Regulation permits.)

Projects with five or less equivalent units	NO FEE
Projects over five equivalent units, to fifteen equivalent units	\$ 50.00
Projects over fifteen equivalent units, to fifty equivalent units	\$100.00
Projects over fifty equivalent units	\$150.00

Minimum Diazo Reproduction Charge . . . . . 2.00

Miscellaneous Diazo Reproduction Sizes:

11 x 17 . . . . .	2.00
17 x 22 . . . . .	2.50
18 x 24 . . . . .	3.00
18 x 36 . . . . .	3.50
24 x 36 . . . . .	4.00
30 x 30 . . . . .	5.00
32 x 32 . . . . .	5.00
36 x 48 . . . . .	6.00
36 x 52 . . . . .	6.00

Mailing charges for maps and documents . . . . . Postage  
(determined on case-by-case basis using effective postal rates)

Minimum Handling and Postage Charge . . . . . 1.00

Section 2. Collection of Fees and Charges.

a. Fees and charges shall be collected by the Brevard County Environmental Services Division for those documents and services furnished by Utilities Engineering, and shall be received in full upon immediate demand prior to the provision of such documents and services.

b. Upon payment for such services, a receipt shall be issued to the payor, a copy of which shall be retained by the payee.

Section 3. Revision of Schedule of Fees and Charges.

The schedule of fees and charges as established herein may, by resolution of the Board of County Commissioners of Brevard County, Florida, be amended or repealed, in whole or in part as required for the economical provision of such services.

Section 4. Public Record and Posting.

a. In accordance with Brevard County Ordinance No. 73-17, a certified copy of this Resolution shall be filed with the Clerk of the Circuit and County Courts of Brevard County, Florida, and shall constitute a public record.

b. A certified copy of this Resolution shall be posted for public inspection in the Brevard County Environmental Services Division, Utilities Engineering.

Section 5. Effective Date.

This Resolution shall take effect on the date of execution.
