In January, 2016, any Brevard County Parks and Recreation parks or facilities located in the City of Palm Bay were conveyed to the City. Brevard County does not own or operate any parks or recreation facilities in the City of Palm Bay.

The Board of County Commissioners has provided direction to staff not to maintain and operate golf courses.
