RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS RATIFYING,
CONFIRMING AND CERTIFYING THE ANNUAL DISPOSAL SPECIAL
ASSESSMENT ROLL AND COLLECTION AND RECYCLING PROGRAM
SPECIAL ASSESSMENT ROLL FOR THE COUNTY FISCAL YEAR
BEGINNING OCTOBER 1, 2025 AND FORWARDING THE SAME TO THE TAX
COLLECTOR'S OFFICE FOR COLLECTION IN THE SAME MANNER AS AD
VALOREM TAXES ARE COLLECTED

WHEREAS, Chapter 94, Article IV., Division 2., Code of Ordinances of Brevard County, Florida, provides that on or before the fifteenth day of September of each year the Board of County Commissioners of Brevard County, Florida, shall certify the Disposal Special Assessment Roll and Collection and Recycling Special Assessment Roll to the Brevard County Tax Collector; and

WHEREAS, an Annual Disposal Special Assessment Roll and Collection and Recycling Program Special Assessment Roll has been prepared, a summary of which is attached to and made a part of this Resolution by this reference, and labeled Exhibit "A"; and

WHEREAS, the Board has reviewed the Annual Disposal Special Assessment Roll Collection and Recycling Program Special Assessment Roll to be sent to the Tax Collector; and

WHEREAS, the Board is satisfied that the Annual Disposal Special Assessment Roll and Collection and Recycling Program Special Assessment Roll has been prepared in conformity with the Schedule of Annual Disposal Special Assessments and Collection and Recycling Program Special Assessments adopted by the Board on August 12, 2025; and

WHEREAS, a copy of such Annual Disposal Special Assessment Roll and Collection and Recycling Program Special Assessment Roll will be sent to the Brevard County Tax Collector for collection in the same manner as ad valorem taxes are collected.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, that:

1. The Board of County Commissioners of Brevard County, Florida, hereby ratifies, confirms and certifies that the Annual Disposal Special Assessment Roll and Collection and Recycling Program Special Assessment Roll for County fiscal year beginning October 1, 2025, is in conformity with the Schedule of Annual Disposal Special Assessments and Collection and Recycling Program Special Assessments adopted by the Board on August 12, 2025.

- 2. The Board of County Commissioners of Brevard County, Florida, hereby certifies, ratifies and confirms such Annual Disposal Special Assessment Roll and Collection and Recycling Program Special Assessment Roll as sent to the Tax Collector. The Tax Collector shall collect such special assessments in the same manner as ad valorem taxes are collected.
- 3. A certified copy of this resolution shall be delivered to the Tax Collector of Brevard County, Florida.
 - 4. This resolution shall take effect immediately upon adoption.
