## Justification:

This Budget Change Request is to establish budget for a grant awarded to the Brevard County Mosquito Control District (Subrecipient) through the Florida Department of Agriculture and Consumer Services (FDACS) (Recipient) from the Centers for Disease Control and Prevention (CDC). The purpose of the CDC Epidemiology and Laboratory Capacity for Prevention and Control of Emerging Infectious Diseases (CK24-0002) Grant is to protect the public health and safety of the American people by enhancing the capacity of public health agencies to effectively detect, respond, prevent and control known and emerging infectious diseases. Specifically, funding is intended for activities pertinent to Project K: Vector-bome Diseases and Tick-Associated Conditions: Building Comprehensive Programs to Identify, Diagnose, Report, Prevent, and Respond. The grant provides equipment for impoundment maintenance and repair, and drone treatment systems. This grant does not require a local funding match.
