

# **Business Impact Estimate**

AN ORDINANCE OF THE BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS AMENDING CHAPTER 94 OF THE CODE OF ORDINANCES OF BREVARD COUNTY, FLORIDA, SPECIFICALLY REVISING CHAPTER 94 – SOLID WASTE, ARTICLE I – IN GENERAL; REVISING SEC. 94-1 - DEFINITIONS TO REPLACE OMITTED DEFINITIONS; REVISING SEC. 94-4 - ENFORCEMENT; PENALTIES TO REPLACE OMITTED PARAGRAPHS 3, 4, AND 5. REVISING ARTICLE II – SOLID WASTE COLLECTION AND RECYCLING; REVISING SEC. 94-47 - RESIDENTIAL SOLID WASTE RECEPTACLES, IMPROPER RECEPTACLES, COLLECTION POINT TO REPLACE OMITTED PARAGRAPH (C); REVISING SEC. 94-76 – CONSTRUCTION, DEMOLITION, LANDCLEARING DEBRIS TO REPLACE OMITTED PARAGRAPHS (C) AND (D).

In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption may apply, Brevard County hereby publishes the following information:

1. Summary of the proposed ordinance: The proposed ordinance accomplishes the following:
  - a) Replaces omitted definitions (94-1).
  - b) Replaces omitted paragraphs concerning violations of the Ordinance and penalties (94-4).
  - c) Replaces omitted paragraphs concerning the collection point location and time solid waste receptacles can be left at the collection point (94-47).
  - d) Replaces omitted paragraphs concerning limited exemptions for the disposal of construction & demolition debris or incineration of landclearing debris (94-76).

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the County, if any:

- a. An estimate of direct compliance costs that businesses may reasonably incur: No impact.
- b. Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible: No new fees.

c. An estimate of the County's regulatory costs, including estimated revenues from any new charges or fees to cover such costs: Costs – none, Revenue – none.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance: Approximately 11,095

Brevard County Code of Ordinances Chapter 94 – Solid Waste was amended in July 2024. Portions of the Ordinance that were not amended were inadvertently omitted from the Ordinance. The August 2025 amendment corrects those omissions.
