SUBJECT: H.14 -Adoption of EAR Based Amendments 2017-2.2 DEO#17-3ER

Item H. 14 is the County's 2017 Comprehensive Plan Evaluation and Appraisal Report which is scheduled to be heard by the Board of County Commissioners at the February 3, 2022, Zoning Meeting. It has come to staff's attention that a Scrivener's Error has occurred in the Transportation Element, when the County Transmitted the Evaluation and Appraisal Report (EAR) to Department of Economic Opportunity (DEO) in 2017. The changes that were mistakenly transmitted to DEO are underlined and highlighted yellow below. County staff recognizes these changes to Transportation Policy 1.3. were done in error, and asks the Board to retain the currently adopted verbiage of the policy.

Transmitted Policy 1.3:

Brevard County shall maintain level of service (LOS) standards for all county arterial and collector roadways.

Criteria:

- A. The level of service standards are as follows:
 - 1. Brevard County arterial and collector roadways within the urban area boundary: Level of Service E for roadways under 35mph. Level of Service D for roadways greater than 35mph.
 - 2. Brevard County arterial and collector roadways within the rural area, except as noted above: Level of Service DC.
 - 3. State arterial roadways (excluding Florida Intrastate Highway System) within the urban area boundary: As adopted by FDOT
 - 4. State arterial roadways (excluding Florida Intrastate Highway System), outside the urban area boundary (rural area): As adopted by FDOT
- B. The level of service standards for the Florida Intrastate Highway System (Interstate 95 and SR 528 shall be established by FDOT. In general, the standards are LOS <u>ED</u> within

the urban area boundary and LOS DC outside the urban area boundary.

Adopted Policy 1.3:

Brevard County shall maintain level of service (LOS) standards for all county arterial and collector roadways.

Criteria:

- A. The level of service standards are as follows:
 - 1. Brevard County arterial and collector roadways within the urban area boundary: Level of Service E
 - 2. Brevard County arterial and collector roadways within the rural area, except as noted above: Level of Service D
 - 3. State arterial roadways (excluding Florida Intrastate Highway System) within the urban area boundary: As adopted by FDOT
 - 4. State arterial roadways (excluding Florida Intrastate Highway System), outside the urban area boundary (rural area): As adopted by FDOT
- B. The level of service standards for the Florida Intrastate Highway System (Interstate 95 and SR 528 shall be established by FDOT. In general, the standards are LOS E within the urban area boundary and LOS D outside the urban area boundary.

Staff has met with the Department of Economic Opportunity to discuss the matter and agree the proposed changes do not require further review and can move forward to the adoption hearing as planned.
