Subject: New Florida Statute Regarding Plat Approvals

Good morning:

I am reaching out to you regarding the new Florida Bill 784 requiring that certain plat or replat submittals be administratively approved with no further action by certain entities under certain circumstances; requiring the governing body of such county or municipality to designate an administrative authority to receive, review, and process plat or replat submittals; requiring the administrative authority to approve, approve with conditions, or deny a plat or replat submittal in accordance with the timeframe in the initial written notice to the applicant. The bill is set to become effective on July 1.

The Crossings at Viera plat is scheduled to go before the Board on July 8 under the current standard procedure that the County has had in place for plat review and approval. I am writing to verify that you would like the plat to continue under the same standard procedure through the Board meeting rather than wait for the County to work through the new statute and designate who the administrative authority for review and approval will be,

and what that new standard procedure will look like. That process could take some time and potentially delay your project.

Please respond with an email stating that you are aware of the new statute, but would still like to continue to the Board under the current standard platting procedures to avoid any potential delays in plat approval caused by implementation of the new statute.
