Justification: This Budget Change Requests increases the Central Fleet budget for countywide fuel expenses and corresponding revenue. Central Fleet purchases fuel for the County's various fuel sites which supply fuel to County Departments, Charter Offices, and outside agencies. Since March 2022, Central Fleet has experienced a \$1.77 and \$1.13 increase in the per-gallon diesel and unleaded fuel, respectively, charged by our supplier. This Budget Change Request will provide sufficient funds for the remainder of this fiscal year topurchase fuel and supply the fuel to County Departments, Charter Offices, and outside agencies. Alternative: Without this change, the budget for fuel will be understated for Central Services, and funding will not be available to purchase fuel for the remainder of the fiscal year.
