Introduction

Space Coast Area Transit is the public transportation provider in Brevard County, Florida. The system operates as a department within Brevard County government under direction of the Brevard County Board of County Commissioners. As a recipient of Florida Department of Transportation (FDOT) Block Grant funding, Space Coast Area Transit must maintain a Transit Development Plan (TDP) to provide a vision for its services over the next 10 years. This executive summary accompanies Space Coast Area Transit's 10-tear TDP for the FY 2023–2032 planning horizon.

Fixed-Route Bus/Trolley

- 23 routes

Demand Response / Paratransit (Door-to-Door)

- Commuter vanpool program—Groups of 7-15 people lease a van at a fixed monthly cost

- Provides transportation for necessary trips



Transit Development Plan Process



While preparing this TDP, Space Coast Area Transit also conducted a Comprehensive Operations Analysis (COA). This detailed assessment of the fixed-route system identified near-term operational improvements to increase efficiency, potentially reduce costs, and improve rider experience. Recommendations from the COA are incorporated into the TDP's 10-year plan.

Mobility on Demand Concept

A service concept called Mobility on Demand (MOD) was evaluated during this TDP. MOD is a real-time shared ride service available to the public within a defined service zone. With recent technology advancements, MOD is emerging as a popular service alternative in areas where fixed-route service may not work well or be cost-effective.

WHAT IS MOBILITY ON DEMAND?

- Door-to-door flex service within a defined service zone
- Open to the public (no approval required)
- Provides first/last mile connections to fixed-route transfer points or bus stops
- Rides requested via mobile app or by phone

Public & Stakeholder Outreach

Public outreach was a key component to completing the Space Coast Area Transit TDP. Different types of activities were used to engage the community and obtain crucial feedback to inform the 10-year plan. This also provided opportunities to introduce the MOD concept and gauge public interest in this technology-based service. Results from two recent transit surveys conducted by the Space Coast Transportation Planning Organization (TPO) regarding transit needs and priorities in Brevard County were also leveraged during this TDP. Collectively 1,750+ participants were engaged through the process.



Transit Service Improvement Priorities



Fixed-route bus service should be extended to 9 PM weekday evenings.

Fixed-route bus headways should be improved to 30 minutes on weekdays.

Fixed-route bus service on Sundays should be provided on all routes.

Transit Vision

To provide all persons living, working, or visiting Brevard County the opportunity to use transit as a safe, affordable, convenient, and sustainable way of traveling.

Transit Mission

Respond to existing and emerging user markets by maintaining current transit service levels while gradually enhancing fixed-route services in the most productive corridors, providing flexible ondemand services in high-need areas where fixed-route service may not be the optimal choice, and implementing sustainable service delivery options, as feasible.

Situation Appraisal

The appraisal examines the strengths and weaknesses of the system, any existing barriers or threats to the provision of transit service in the county, and key opportunities for addressing those threats and/or enhancing the perception of transit within the operating environment.

Findings were considered in identifying potential transit alternatives, including ongoing plans and projects and input from agency staff.

Transit goals, objectives, strategies, and targets re-emphasize the agency's existing priorities and outline new priorities for improvements based on transit needs.

Transit Demand Assessment

The demand analyses, together with the baseline conditions assessment and performance reviews, assisted in identifying areas with transit-supportive characteristics.





COA (Operations Analysis)

An assessment was conducted to identify short- and mid-range strategies to improve service and operational efficiencies, enhance connectivity, increase customer satisfaction and ridership.



10-Year Financial Plan

The 10-year financial plan guides and supports decision-making by Space Coast Area Transit/the Brevard County Commission regarding service, capital, and other improvements over the next 10 years.

The 10-year plan is balanced for FY 2023 based on the agency's proposed operating and capital budget; beyond the first year, the plan includes annual costs for service and capital improvements programmed for implementation within the next 10 years, together with supporting revenues that are reasonably expected to be available to fund their implementation. As this is not a budget, the identified implementation plan may be adjusted as priorities shift, funding assumptions change, or additional funding becomes available.

10-Year Transit Plan Highlights



\$165.2 million to operate the redesigned and expanded system.



\$213.4 million for capital expenses, including technology, vehicles, etc.




\$339.1 million in revenue from existing and potential new sources.



\$39.5 million in unfunded needs over the 10-years.

This plan does not establish a financial commitment by Brevard County and the Board of County Commissioners must approve each fiscal year budget annually.


