

AMENDMENT #7
TO THE FLEET MAINTENANCE AND MANAGEMENT CONTRACT BETWEEN
THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA
ON BEHALF OF SPACE COAST AREA TRANSIT
AND
FIRST VEHICLE SERVICES, INC.

This Amendment is made this 7th day of July, 2020 by and between the Board of County Commissioners of Brevard County, Florida on behalf of Space Coast Area Transit ("the County") and First Vehicle Services, Inc. ("the Contractor").

WHEREAS, the current term of Contract (#2969) expires on July 31, 2020; and

WHEREAS, the County and the Contractor now desire to amend the Current Contract (#2969) and extend the term of the Contract for an additional 90 days in order to provide the County additional time within which to solicit new proposals for the services contemplated under the Contract; and

NOW, THEREFORE, in consideration of the mutual covenants, promises and undertakings in the Contract, Amendment #1, Amendment #2, Amendment #3, Amendment #4, Amendment #5, Amendment #6 and this Amendment #7, the County and the Contractor agree to amend and reaffirm the contract as follows:

1. That the term of the Agreement as provided in, Section 2. TERM, shall be until October 30, 2020.
2. This Amendment supersedes all oral negotiations and prior contemporaneous writings with respect to the subject matter hereof and is intended by the County and Contractor as the final expression of the agreement with respect to the terms and conditions set forth herein and as the complete and exclusive statement of the terms agreed to by the County and Contractor. If there is any conflict between the terms, conditions, and provisions of this Amendment and those of any other agreement or instrument, the terms, conditions and provisions of this Amendment shall prevail.

Except as expressly amended by this document, the Contract as previously executed remain in full force and effect and legally binding upon the County and the Contractor.
