 - Trained over 700 County and School Board personnel between July 2017 – April 2018

- Worked with the State Animal Response Coalition to secure enough donated pet shelter supplies to stock four Pet-Friendly Shelter trailers
- Coordinated the Hurricane Irma Response Recognition effort that included the distribution of certificates, pins and special lanyards for over 1200 individuals
- Developer of the Brevard County Multi-Year Training and Exercise Plan that was identified as an Emergency Management Accreditation Program (EMAP) best practice
- Co-designed twelve hurricane exercises that focused on specific functions, partner agencies and the critical processes or mechanisms necessary to perform their tasks
