However, due to Covid-19, and the closing of the center for an extended period of time, the above services were placed on hold. At the time of renewal, there was an issue with the verbiage of the insurance, deadline, etc. However, since there is still no private school in the East Mims community, we feel there is still a need and we would like to come share our knowledge and extend educational services to this community. We are working on God's plan and want to continue to build his kingdom by helping the youth become: doctors, lawyers, teachers, nurses, police, firemen and future entrepreneurs. If you would give us this opportunity once again, we would help fill the gap of educational and academic needs in the North Titusville/ East Mims community.
