MEMORANDUM OF UNDERSTANDING: DMS-21/22-031 BETWEEN STATE OF FLORIDA, DEPARTMENT OF MANAGEMENT SERVICES AND BREVARD COUNTY, FLORIDA

AMENDMENT No. 1

This Amendment to Memorandum of Understanding (Amendment) is to extend the term of the Memorandum of Understanding (MOU) between the Florida Department of Management Services (the "Department"), a state agency, and Brevard County, (the "County") a political subdivision of the state of Florida created pursuant to Florida Statutes, collectively referred to herein as the "Parties".

WHEREAS, L3Harris Technologies, Inc., (L3H), formally known as Harris Corporation, is the operator of a Florida Statewide Law Enforcement Radio System network (SLERS) in accordance with the terms of Contract No. 725-001-01-1, the Service and Access Agreement for the SLERS network dated September 28, 2000, between the Department and L3H, as amended.

WHEREAS, on December 22, 2009, the County received federal money from the Public Safety Interoperability Communications Grant through a grant agreement with the Florida Division of Emergency Management to build the Region V IO Network.

WHEREAS, in accordance with section 282.702(3), Florida Statutes, the Parties executed the MOU on August 23, 2011, for the installation, maintenance and operation of interconnection equipment (Interconnection) between Region V IO Network and SLERS at the Ironbridge facility.

WHEREAS, the purpose of the MOU was to describe the mutual goals and responsibilities regarding the installation, maintenance, and operation of the Interconnection that allows the County access to SLERS Interoperability Talk Groups.

WHEREAS, the Department had no obligation to pay expenses incurred during the implementation or operation of the Interconnection for the term of the MOU. The Interconnection used and installed by the County was at the County's sole expense.

WHEREAS, the original term of the MOU continues through the end of June 30, 2021, unless terminated earlier by mutual agreement, and may be extended by mutual written consent of the Parties.

NOW, **THEREFORE**, the Parties hereto mutually agree to the following amendments to the MOU:

- 1. All references to "Harris Corporation" and "Harris" shall be replaced with "L3Harris Technologies, Inc." and "L3H," respectively.
- 2. The term of this MOU is extended through **June 30**, **2036**, unless terminated earlier pursuant to the provisions of this MOU. At the conclusion of this period, this MOU may be extended by mutual written consent of the Parties hereto. The MOU may be terminated by either party, with or without cause, upon at least ninety (90) days written notice to the other party.

Except as specifically set forth in this Amendment, the MOU is otherwise unmodified and remains in full force and effect and is hereby ratified and reaffirmed. In the event of any inconsistencies between the MOU and this Amendment, the terms of this Amendment shall take precedence.
