

## ASSIGNMENT OF AGREEMENT

1. The above recitals are true and correct and are incorporated herein, in their entirety by this reference.
2. All rights, title and interest in the Agreement between Brevard County and Bussen-Mayer/Assignor are hereby assigned and transferred to D.R.M.P./Assignee, and D.R.M.P./Assignee accepts said assignment and agrees to perform all obligations of Bussen-Mayer/Assignor under the Agreement.
3. D.R.M.P./Assignee agrees to abide by all terms, prices and conditions of the Agreement.

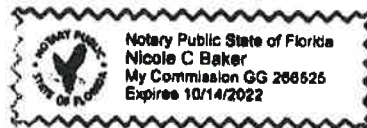

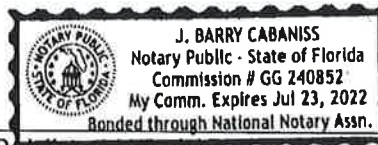
