## A. CALL TO ORDER 5:30 PM

#### D. PUBLIC HEARINGS

Chair Lober stated he wanted to take a moment to discuss Public Comment as he knows there were some questions that came up with respect with it today; there is not a general Public Comment portion of the Agenda, so if there is something that addresses one of the Items on the Agenda, please submit a card for that Item; but since it is a limited purpose hearing today, for budget issues, the comments are restricted to something that is on the Agenda; and he does not want someone to sit and wait needlessly to talk about something else that will not be permitted. He also wanted to state that all Public Comments will be three minutes; the sheet notes five minutes per speaker but that is for quasi-judicial proceedings; and he asked Eden Bentley, County Attorney, if there were any quasi-judicial Items on the Agenda.

Ms. Bentley replied no.

## D.1. Announcement of the Percentage Change in the FY 2020-2021 Aggregate Tentatively Adopted Millage from the Aggregate Rolled-Back Rate

Chair Lober called for a public hearing to acknowledge the announcement of the percentage change in the FY2020-2021 aggregate tentatively adopted millage from the aggregate rolled-back rate.

Frank Abbate, County Manager, stated Item D.1., allows for the reading of the tentative aggregate operating millage rate to fund the portion of the Fiscal Year 2020 2021 budget that is supported by Property Taxes; and he asked Jill Hayes, Budget Office Director, to read into the record the tentative aggregate millage for Fiscal Year 2020 2021.

Jill Hayes, Budget Office Director, stated the aggregate tentative millage rate for the Fiscal Year 2020 2021 budget is 5.6404 mills; and this represents a 1.35 percent decrease from the aggregate rolled back millage of 5.7176 mills.

There being no comments, the Board acknowledged the announcement as read into the record that the aggregate rolled-back rate for Fiscal Year 2020-2021 is 5.7176 mills, the aggregate tentative rate is 5.6404 mills, and the percentage change is 1.35 percent, including voted millages.

#### D.2. Public Comment: RE: Revised Tentatively Adopted County Operating and Capital Budget for FY 2020-2021

Chair Lober called for a public hearing on public comment, re: revised tentatively adopted County operating and capital budget for FY2020-2021.

Frank Abbate, County Manager, stated Item D.2. allows for the public to comment on the County budget for Fiscal Year 2020-2021; and before public comments begin, he would ask the Budget Office to read into the record the Fiscal Year 2020-2021 Budget.

Jill Hayes, Budget Office Director, stated the Fiscal Year 2020-2021 budget is \$1,485,676,587; the budget represents a decrease of \$85,182,859 or 5.42 percent less that the Fiscal Year 2019-2020 current budget of \$1,570,859,446.

Mr. Abbate stated the Board is now ready to accept public comments on the budget for Fiscal Year 2020-2021.

Chair Lober stated he needed clarification on D.2., the second page of the Agenda sheet; and he asked if anything changed, to make sure everyone was on the same page, since there have been a couple different versions of the document.

Jill Hayes, Budget Office Director, replied yes; she thanked him for bringing it up; there was a scrivener's error in the table in the first version of the Agenda; and that has been corrected.

Chair Lober stated he understood the error only pertained to the first row, the four columns on the right; and asked Jill Hayes, Budget Office Director, if that was correct.

Jill Hayes, Budget Office Director, replied yes; and she advised it was the column headings on the table.

Chair Lober asked Jill Hayes, Budget Office Director, if the number values were all correct.

Jill Hayes, Budget Office Director, replied yes.

Michael Bramson, President of the Brevard County Fire Fighters Union, stated he is present to speak on the budget for 2020-2021; included in the budget was going to be an increase to the fire fighter salary base rate increase that was negotiated through an open meeting with a team and led by Jerry Visco, Human Resources Director; he intends to explain the intent of the negotiations and negotiations moving forward which will begin October 6, 2020; it is his and the Union's desire to make sure a contract is negotiated to allow for the survivability of the Fire Department to perform its job and respond to emergencies that the citizens and visitors of Brevard County expect to be responded to; and there is an expectation of service when someone calls 911. He added there is an increase to salary, but it is not personal wealth that is the intent of these negotiations, it is the survivability of the Fire Department in Brevard County to respond to the increasing risks and hazards on the Space Coast moving forward into 2021.

Charles Tovey stated he spoke last week about the beach sand and he brought some pictures to share with the Board; he asked the Board to consider making a decision about the beach sand; he stated by looking at the pictures, it can be seen that the sand that was put down is now gone; it was two or three weeks ago and two weeks later, there is no sand left; that is all he has for tonight; he mentioned these were the only clothes he had; and why they took his clothes is beyond him.

Mr. Abbate stated it is recommended that the Board of County Commissioners discuss the budget at this point; and since the Board must adopt the millages and related budgets separately, comments and motions concerning individual tax levies can also be made at the time each millage is adopted.

There being no further comments, Board accepted public comments concerning the tentatively approved Operating and Capital Budget for the County's 2020-2021 Fiscal Year, including Charter Officers and Dependent Special Districts.

#### D.3. Public Comment, Discussion and Adoption of the Resolution Establishing Final Millages for FY 2020-2021 for Brevard County

Chair Lober called for a public hearing on public comment, discussion, and adoption of the Resolution, re: establishing final millages for FY2020-2021 for Brevard County.

Frank Abbate, County Manager, stated Item D.3. allows for public comment, discussion, and adoption of the final millages for Fiscal Year 2020-2021; and if there are any Public Comments on Item D.3., now would be an appropriate time to hear those comments.

Peter Carnesale stated he got an answer to what the final millage was when it was read aloud; he had more of a question as he did not hear the percentage rate; and it sounded like it was a percentage rate difference from the temporary millage rate as opposed to last year's millage rate.

Jill Hayes, Budget Office Director, stated the Florida Statutes require that the tentative millage rate is read into the record, which was 5.6404; it also requires it is stated how that compares to the rolled back millage, which is a State required calculation; and when it is compared to the current millage rate, it represents a 3.5 percent reduction from the current Fiscal Year aggregate rate of 5.8447.

Chair Lober advised Mr. Carnesale that Brevard County itself is only one taxing authority; and there are other taxing authorities as well, so it is impossible for anyone to say that someone's taxes will go up or down when it is taken as a whole.

Mr. Carnesale stated he was looking for how much the home values increased over the past year, that will be applied against; and he is not sure whether Jill Hayes, Budget Office Director, has that or whether he needs a name and a number.

Ms. Hayes explained the property values increased by close to nine percent, however, because of the Charter cap, the millage rate actually decreased because it is required to stay within the Consumer Price Index in terms of the revenue that can be levied.

Mr. Carnesale stated basically, it is not going to be that rate against the number of over nine percent; basically that is how to determine the tax number; it would be taking the value in thousands, and matching that against the millage rate, multiplying it out, and that becomes the tax; what he is looking for is an estimate of those two numbers in an aggregate; and he knows it cannot be given to him as house by house or neighborhood by neighborhood so that he could get an estimate Countywide of what that actually calculates out to.

Chair Lober asked Jill Hayes, Budget Office Director, if she recalled the Delta; and he knows it was not a huge one.

Ms. Hayes stated she is not sure if she understands the question; each individual property would have to be looked at like the property valuation and take into account any exemptions; it would need to be looked at on a case-by-case basis; and then apply the millage rate for that geographic area.

Chair Lober stated Mr. Carnesale could speak with staff after the meeting; with respect to an average \$200,000 house, with a caveat that the Board does not control all of the taxes because it is one out of several different taxing authorities in the area, some which tax and some which do not, but from the County's perspective for the County taxes that are applied; and he asked Jill Hayes, Budget Office Director, if it is a fair statement to say that there will at least be a number of individuals and houses who pay less actual dollars to the County in the form of taxes this coming year as opposed to the current year.

Ms. Hayes replied she thinks that is a fair statement to say that a large portion, especially those

with a homestead exemption, would see a decrease in what they pay in County taxes, because every millage rate did decrease; to use the example of the \$200,000 home, applying the current aggregate rate to that same taxable value with the tentative aggregate rate would be about a \$41 decrease for a taxable value of around \$200,000; and she would like to make a clarification, as she had said it was close to nine percent on the increase in property valuation, and it was actually 7.21 percent for the County as a whole.

Mr. Abbate stated to the Board the Budget Office will now read into the record the millage and related Ad Valorem revenue for each taxing authority; and following the reading of each tax levy, it is requested that the Chair entertain a motion for approval of that millage.

#### General Fund

Jill Hayes, Budget Office Director, stated for the General Fund Countywide, the Fiscal Year 2020 2021 Tentative Millage is 3.6929, which represents a 0.76 percent change from the rolled back millage of 3.6649, generating \$161,307,346 in Ad Valorem revenue.

Chair Lober inquired of Mr. Abbate in respect to this, is it necessary that these are voted on individually.

Mr. Abbate replied yes, he believes it is.

There being no further comments, the Board approved the final millage for the General Fund at 3.6929, and revenue at \$161,307,346.

Brevard Library District

Chelsea Rollyson, Budget Senior Analyst, stated for the Brevard Library District, the Fiscal Year 2020 2021 tentative millage is 0.4264, which represents a 0.33 percent change from the rolled back millage rate of 0.4250, generating \$18,759,607 in Ad Valorem revenue.

There being no comments, the Board approved the final millage for the Brevard Library District at 0.4250, and Ad Valorem revenue at \$18,759,607.

There being no comments, the Board approved the final millage for the Brevard Mosquito

District at 0.1728, and Ad Valorem revenue at \$7,602,392.

Chelsea Rollyson, Budget Senior Analyst, stated for the Fire Control MSTU District, the Fiscal Year 2020 2021 tentative millage is 0.6141, which represents a 1.45 percent increase from the rolled back millage of 0.6053, generating \$13,120,059 in Ad Valorem revenue.

There being no comments, the Board approved the final millage for the Fire Control MSTU at 0.6053, and Ad Valorem revenue at \$13,020,059.

Jill Hayes, Budget Office Director, stated the aggregate millage rate for Fiscal Year 2020 2021 budget is 5.6404 mills which represents a 1.35 percent decrease from aggregate rolled back rate of 5.7176.

Mr. Abbate stated the Budget Office will read into the record a resolution establishing the County's final millages for Fiscal Year 2020 2021; and following the reading of the resolution it is requested the Chair entertain a motion for approval of the resolution.

There being no further comments or objections, the Board accepted public comment, discussed, and adopted Resolution No. 20-115, establishing the final millages for FY 2020 2021.

There being no comments, the Board executed and adopted Resolution No. 20-116, establishing the final budget for Fiscal Year 2020-2021.

Attorney Bentley responded she thinks it has to be accounted for in terms of business; and even if there is no change, it has to be put in there.

## E.1. FY 2020-2021 Annual Certified Budget for Arthropod Control (All Districts)

Joseph Faella, Mosquito Control Director, stated this is Mosquito Control's Annual State Certified Budget for Arthropod Control; it is a fiscal impact of \$10,743,485 for Fiscal Year 2020 2021; Chapter 388, Rule 5(e)13, Florida Administrative Code, requires them to submit this annual budget to the Florida Department of Agriculture and Consumer Services, by September 30, of every year to continue operating as a certified Mosquito Control District; this is the same budget that was approved earlier in the meeting but is under the Agricultural Department format; and he is requesting that the Board approves and authorizes the Chair to execute the Certified annual budget.

The Board executed and approved the State of Florida, Department of Agriculture and Consumer Services (FDACS), Annual Certified Budget for Arthropod Control (FDACS Form 13617, Rev. 07/13) for Fiscal Year October 1, 2020 to September 30, 2021.
